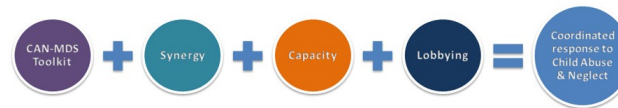


Many countries have set up statistical observation mechanisms for the populations of children in danger or receiving help from child welfare services that are tailored to their institutional, legal and social contexts. The international conference organized by ONED aims to give the floor to the experts who oversee these mechanisms so as to understand their respective advantages and limitations. To this end, speakers from the United States, Germany, France, Denmark and Greece have been invited. This conference will conclude with a presentation of the European surveillance tool designed through project “Coordinated Response to Child Abuse and Neglect via Minimum Data Set”, which has received financial support from the European Union.
